Notice No: 03 of 2014-2015 of DD(EP-IV) /WBHB

Sealed quotations are invited from bonafide resourceful agencies having experience in similar nature of work mentioned below:

1. Name of work: Demand Survey of West Bengal Housing Board's proposed Housing Project, at Bidhannagar, Durgapur, Mouza: Gopinathpur, Dist:Burdwan, under DMC and ADDA jurisdiction, will be undertaken shortly. This poject is coming up in Bidhannagar (opposite Bengal Engineering College) adjacent to "Annapurna Abasan" within 10 minutes drive from Durgapur Railway Station, within close proximity of the hubbub of city.

2. Distance From:

- i) Durgapur Railway Station: 7 Km.
- ii) School/College Within and around 1 km(approx) Bengal Engineering College, Durgapur Public School, Bidhannagar School, Carmel High School.

Each flat consists of 3 No Bedrooms, Hall, Kitchen, Two no Toilets(One no. attached and One no. common), Balcony, with all modern fittings and fixtures to cater to High Income Group consumers.

- 10) Earnest Money: Minimum 2(two) percent of the quoted total rate to be deposited by Bank Draft/Pay order on a Kolkata Bank drawn in favor of W.B. Housing Board which will be converted into part security deposit for successful agency. Balance security amount to constitute a total security deposit of 10% of the total quoted amount will be deducted proportionately from the progressive bill amount of the agency. The entire security deposit will be released after six months of the date of completion of the work .
