NOTICE INVITING QUOTATION Notice No: 05 of 2014-2015 of DD (EP-IV)/WBHB SECOND(2nd)CALL

Sealed quotations are invited afresh from bonafide resourceful agencies having experience in similar nature of work mentioned below:

- 1. Name of work: Consultancy Service for Preparation and submission of Detail Structural Design and Drawing, of Proposed 1)Residential(Two no G+IV Blocks) & Residential-cum-Commercial Building(One no G+IV Block) with associated structures and Service facilities at Matkal-Nimta Housing Project, Phase-II and (2) One no.Residential (G+VI) Block with associated structures and service facilities at Himalayakannya Phase-1HP. at Siliguri and (3) One no. (G+IV) Residential cum Commercial Building with associated structures and service facilities at Amulyakanan HP. at Serampore of West Bengal Housing Board including obtaining sanction and completion certificate of all the Buildings from the competent Sanctioning Authorities on the basis of Architectural Drawings of WBHB.
- . 2. The intending Agency has to submit self attested copy of valid Pan Card, I.T. Return, Professional Tax clearance certificate Service Tax Registration certificate and Credential certificate for a minimum Value of Rs 3.50 (Three and half) Lac for a single Structural Design Consultancy work for a Multistoried Building done within last five years along with the application.. Payment Certificate/Completion Certificate showing value of work and completion period and full address of the Client organization may be submitted as Credential Certificate along with other relevant papers relating to the work done along with the application for permission for procurement of BID DOCUMENT which will be issued free of cost. Application for permission for procurement of BID DOCUMENT may be addressed to the DY. Director (EP)-IV/WBHB within the date and time and with all relevant documents as specified in the NIQ.

3. <u>Technical Manpower Deployment:</u>

The consultant shall have to deploy the following key technical personnel for carrying out the consultancy services in connection with the project if the contract is awarded to them.

1. Project Architect(One no). 2. Structural Engineers(One no) 3. Geotechnical Engineer(One no).4.Public health Engineer(One no). 5. Mechanical Expert for Fighting Engineering.(One no). Minimum Qualification of Project Architect, Structural Engineer and Geotechnical Engineer should be Graduate in Architecture/ Engineering and minimum professional experience should be two years in respective fields.

The Bidders have to submit an undertaking duly and completely filled up and signed by the signatory of the Bidder by stating name, qualification and experience of the key Technical Personnel as stated above in a specified format and designation given in the **Annexure** of the present second call of the NIQ along with the application for permission for procurement of BID DOCUMENT.

- 4. Bidder should submit self attested copy of a written power of attorney authorizing the signatory of the bid to commit the bidder if required along with the application for purchase of. of BID DOCUMENT.
- 5. The Consultant shall have a Permanent Office at Kolkata or at surrounding districts in West Bengal. Self attested copy of a valid document showing address proof of the office must be Enclosed along with the application for procurement of BID DOCUMENT.
- 6. BIDDER must sign all pages of BID DOCUMENT with his designation and seal before submission of BID DOCUMENT to the Quotation inviting authority.
- 7.. Last Date and time limit of receipt of application : 10.04.2015. (up to 2.00 pm.) for permission for procurement of BID DOCUMENT .
- 8.. Last Date and time limit of procurement of BID DOCUMENT: 13.04.2015. (up to 4.00 pm.)
- 9. Last Date and Time Limit for submission of BID DOCUMENT: 16.04.2015 (up to 2..00pm)
- 10. Date and Time of opening of BID DOCUMENTS: 16.04.2015 (3.00 pm)
- . 11. Rate to be quoted against each individual Work/Block according to the Annexed Schedule given in the BID DOCUMENT. The lowest quotation will be selected on the basis of Total rate quoted against the whole assignment. The BID DOCUMENT duly filled up and signed along with the Earnest Money Deposit may be deposited in a sealed envelope to the tender box lying in the chamber of DD (EP-IV) within the stipulated date and time. Period of completion of total work may be taken as four years from the date of issue of Work order.

- 12. **Earnest Money**: Minimum Two percent of the Quoted amount to be deposited by Bank Draft/Pay order on a Kolkata Bank drawn in favor **WEST.BENGAL.HOUSING BOARD** which will be converted into part security deposit for successful agency. Balance security amount to constitute a total security deposit of 10% of the total quoted amount will be deducted proportionately from the progressive bill amount of the agency. The entire security deposit will be released after six months of the date of completion of the work.
- 13. In case of second call of the NIQ, the Bidders who have deposited the requisite Earnest Money along with his BID DOCUMENT earlier in accordance with the original NIQ and has not withdrawn such Earnest Money shall not be required to deposit further Earnest Money along with the BID DOCUMENT for participating in the second call of NIQ. However for any reason if the amount of EMD already submitted falls short of the Minimum amount of EMD as stipulated in Clause. No: 12 of the NIQ, the balance amount of EMD shall have to be deposited along with the BID DOCUMENT as mentioned in the relevant Clause.
- 14. In case of second call of the NIQ, the Bidder who has submitted the Credentials along with other relevant documents seeking permission for purchase of BID DOCUMENT in the original NIQ, need not submit the same except duly filled up and signed "UNDERTAKING FOR TECHNICAL MANPOWER DEPLOYMENT" as specified in Clause 3.and given in the Annexure of the present second call of the NIQ which is required to be duly and completely filled up, signed and submitted along with the Application for permission for procurement of BID DOCUMENT.
- 15. The successful agency will have to execute formal agreement in **Tender and Contract Form of WBHB** with applicable amendments in Triplicate after issuance of work order.
- 16. No conditional quotation will be considered for acceptance.
- 17. Quotation inviting authority may reject any /all the quotations without assigning any reason.
- 18. Service tax will be paid by the successful agency to the relevant Authority and WBHB will reimburse the same on production of necessary documents.
