2.	Eligibility criteria:	Intending Bidders should produce credentials of a similar nature of services for at least one work under Govt. Sector, Semi Govt. Sector, Corporations, Govt. Companies, Boards, Autonomous/Statutory Bodies, Reputed Bank, Local Bodies, etc. and having a magnitude of 30%(Price updated @10% per annum, compoundable from the date of completion of work) of the Work value put to Tender during 5(five) years prior to the date of issue of this Tender notice of similar nature.

 - Professional Tax (PT) challan.
 - VAT registration particulars (Form no 3).
 - The prospective bidder would also have documents in support of valid Provident fund enrolment No. issued by appropriate authority.
 - Service Tax registration particulars.
 - Valid Trade license.
 - Power of Attorney/Authority to sign the Tender document & Article/Memorandum of Association (in case of Companies).
 - Partnership Deed In case of Partnership firm.
 - Credential of past experience of similar nature of works.
- **14. Quotation documents can be available from** the office of the Deputy Director (EW)-SKHP, West Bengal Housing Board, 105, S.N. Banerjee Road(ABASAN, 4th floor) Kolkata-14. The Agency will quote the rate (in both words and figures) in the prescribed form of WBHB of the Quotation documents.
- **15. Quotation must be accompanied by EMD** specified for the work in the shape of Bank Draft/Pay Order only on a Nationalized **Bank drawn in favor of West Bengal Housing Board payable at Kolkata**.
- **16**. **Quotation must be delivered to Deputy Director (EW)-SKHP,** West Bengal Housing Board (As mentioned in sl. No.14) or in absence to any authorized officer of West Bengal Housing Board and will be opened on the same day in the presence of bidders or their authorized representatives.
- **17.** If the office happens to be closed on the date of receipt of tender as specified in the NIQ will be received and opened on the next working day at the same time and venue.
- **18**. **Service Tax on Maintenance work @ 10.50**%may be reimbursed by West Bengal Housing Board on receipt of relevant Document.
- **19**. **The post tendering negotiation** if required may be made with all the eligible quotationers which may be instant or afterwards.
- **20**. **The agency shall have to provide** everything necessary for proper execution of the work including labour, materials (Bleaching powder), tools & tackles(Trolley van, baskets, buckets, brooms, sickles, spades, etc.) for providing conservancy services as specified in the item.
- **21**. **There will be no provision for arbitration** whatsoever in the contract.
- **22**. **Successful Quotationer would have to execute an agreement** as specified by the WBHB in non-judicial stamp paper of value Rs. 10/-only before issuing of formal work order by the WBHB.
- 23. No conditional Quotation will be accepted.
- **24**. **Quotation will be received only in the tender box** kept in the office chamber of Deputy Director (EW)-SKHP, West Bengal Housing Board, 105, S.N. Banerjee Road, ABASAN (4th floor), Kolkata-700014 and nowhere else,

- **25**. **Submission of false misleading** and fabricated statement/ documents/information etc. found at any point of time will lead to cancellation of the Quotation.
- **26**. **Acceptance of Quotation will rest entirely with the WBHB** which does not bind itself to accept the lowest tender and reserves the right itself the authority to reject any or all the **Quotations** received without assigning any reasons thereof.
- **27. Bidder should Quoted their Rate,** shall have to comply with the provisions of Minimum wages Act. 1948 (vide Memorandum no 3687-F(Y), Dated 02.05.2012 and Memorandum no 3790-F(Y) Dated 21.07.2014) and also to comply the Minimum wages rate of Lobour Commissioner, Govt.of West Bengal circulated vide no.1242/STAT/2RW/76/266/2000/LCS/JLC dated 02.07.15 with effect from 1st July 2015 including all the Statutory Levis as per Govt. Order.
- **28. Refund of EMD:** The Earnest Money of all the unsuccessful Quotationers deposited along with the Quotations will be refunded by the Quotation Inviting Authority on receipt of application from tenderer for such refund after issuance of work order to the successful bidder.
- 29. The Minimum Man Power Deployment should be:

a) Plumbing Mistry(Skilled category) : 01 (One) no.
 b) Methor Mazdoor(Un-Skilled category) : 05 (Five) nos.
 c) Cycle Van /Trolley operator : 01(One) no.
 d) Supervisor(Skilled Category)for monitoring the system : 01(One) no.

- **30.** The employees of the agency shall be covered under the "Employee Risk Insurance scheme" and the charges shall be borne by the agency.
- 31. No Mobilisation Advance and Secured Advance will be allowed.
