iv) Service Tax registration certificate/Documents related with Service Tax Registration.

v) Valid Trade license from respective Municipality/Panchayat,

vi) Power of Attorney/Authority to sign the Tender documents (in case of partnership firm) and Articles/Memorandum of Association (in case of companies)

vii) Partnership Deed- (In case of partnership firm.)

13. The Agency will quote the rate (in both words and figures) in the prescribed form of WBHB of the Tender documents,

14. Tender must be accompanied by EMD specified for the work in the shape of Bank Draft/Pay Order only on a Nationalized **Bank drawn in favor of West Bengal Housing Board payable at Kolkata**. E.M.D. Should be kept in a sealed envelope with a clear description and should accompany the name of work and N.I.T. No.

15. **Tender must be delivered to Joint Director (EW) -I**, at 4th floor ABASAN building 105 S.N.Banerjee Road Kol-700014, West Bengal Housing Board or in absence to any authorized officer of West Bengal Housing Board and will be opened on the same day in the presence of bidders or their authorized representatives.

16. **If the office happens to be closed on the date of receipt of tender** as specified in the NIT will be received and opened on the next working day at the same time and venue,

17. **The post tendering negotiation** if required may be made with all the eligible tenderers which may be instant or afterwards.

18. **Contractor shall have to make his /her own arrangement for resource materials** like steel and cement required for the work. .

19. **There will be no provision for arbitration** whatsoever in the contract.

20. **Successful tenderer would have to execute an agreement** as specified by the WBHB in non- judicial stamp paper of value Rs. 10/-only before issuing of formal work order by the WBHB

21. No conditional tender will be accepted.

22. Service Tax will be reimbursed provided the Agency is having be service Tax Registration number.

23. **Tenders will be received only in the tender box** kept in the office chamber of Joint Director (EW)- I, West Bengal Housing Board, 105, S N Banerjee Road, Abasan (4th floor), Kolkata-700014 and nowhere else,

24. **Submission of false misleading and fabricated statement/ documents/information** etc found at any point of time will lead to cancellation of the tender.

25. **Acceptance of tender will rest entirely with the WBHB** which does not bind itself to accept the lowest tender and reserves the right itself the authority to reject any or all the tenders received without assigning any reasons thereof.
