Deputy Director (EW) Maniktala Housing Project under West Bengal Housing Board. invites sealed tender in prescribed form from eligible bidders for the works as per particulars below:-

1.	Name of work:	Installation of 32 N0s. sign boards 50 Nos. Pillars at Sunray Moon Beam, 3.95 Acrs of Land and other vacant land at Newtown Rajarhat under W.B.H.B.
2.	Eligibility criteria:	Bonafide & resourceful contractor's working in W.B.H.B. state P.W.D., C.P.W.D., railway, having credentials for execution of similar nature of satisfactory completed works valued at least 40% of estimated amount in a single contract during last five years. Or intending tenders should product credentials of 2 (Two) similar nature of work, each of the minimum value of 20% of the estimated amount put to tender during 5(Five) years period to the date of issue of the tender notice, or Intending tenderes should produce credentials of one single running work of similar nature which has been completed to the extent of 80% or more and value of which is not less than the decided value at i) above. In case of running works, only those tenderers who will submit the certificate of satisfactory running works from the concerned Executive Engineer, or equivalent competent authority will be eligible for the tender, In the required certificate it should be clearly stated that the work is in progress satisfactorily and also that no panel action has been initiated against the executed agency, i.e. the tenderer. ii)Professional Tax (PT) latest challan with certificate

- iii)Employees provident Fund (PF) enrollment certificate with code no and last receipt.
- iv) Sale Tax/VAT registration particulars (From no.3) and latest value added Tax deposit challan
- v)Service Tax registration certificate. With latest deposit challan
- vi)Work order and Completion certificate from respective department.

vii)Valid Trade license from respective Municipality/Panchayat,

viii)Power of Attorney/Authority to sign the Tender documents and

Articles/Memorandum of Association (in case of companies)

ix)Partnership Deed- (In case of partnership firm.)

iix) Valid Tread licence

14. Tender documents can be available from the office of the Dy, Director (EW)- Maniktala Housing Project on receipt of cost of Tender paper.

The Agency will quote the rate (in both words and figures) in the prescribed form of WBHB of the Tender documents,

- 15. Tender must be accompanied by EMD specified for the work in the shape of Bank Draft/Pay Order only on a Nationalized Bank drawn in favor of West Bengal Housing Board payable at Kolkata. E.M.D. Should be kept in a sealed envelope with a clear description and should accompany the name of work and N.I.T. No.
- 16. Tender must be delivered to Deputy Director (EW) Maniktala H.P. West Bengal Housing Board or in absence to any authorized officer of West Bengal Housing Board and will be opened on the same day in the presence of bidders or their authorized representatives.
- 17. If the office happens to be closed on the date of receipt of tender as specified in the NIT will be received and opened on the next working day at the same time and venue,
- 18. The post tendering negotiation if required may be made with all the eligible tenderers which may be instant or afterwards.
- Contractor shall have to make his /her own arrangement for resource materials
 like steel and cement required for the work. Branded steel and cement (steel:
 SAIL/TATA/RINL brand and cement: ULTRAECH/AMBOOJA/LAFARGE Brand)
 duly certified will only be accepted.
- 20. There will be no provision for arbitration whatsoever in the contract.
- 21. Successful tenderer would have to arrange cess registration certificate with the labour Department, Government of West Bengal located in the area where the construction project/work is to be executed under specific NIT.
- 22. Successful tenderer would have to execute an agreement as specified by the WBHB in non- judicial stamp paper of value Rs. 10/-only before issuing of formal work order by the WBHB
- One percent (1%) cess will be statutorily deducted from each of contractor's progressive bill.

- 24. No conditional tender will be accepted.
- Service Tax be reimbursed provided the Agency is having be service Tax Registration.
- 26.Tenders will be received only in the tender box kept in the office chamber of Joint-Director (EW)-I, West Bengal Housing Board.105,S N Banerjee Road, Abasan (3rd floor), Kolkata-700014 and nowhere else,
- 27. Submission of false misleading and fabricated statement/ documents/information etc found at any point of time will lead to cancellation of the tender.
- 28. Acceptance of tender will rest entirely with the WBHB which does not bind itself to accept the lowest tender and reserves the right itself the authority to reject any or all the tenders received without assigning any reasons thereof.
