Deputy Director (EW) Siliguri Housing Project under West Bengal Housing Board. invites sealed tender in prescribed form from eligible bidders for the works as per particulars below:-

Eligibility criteria:	Bonafide & Resourceful Contractor working in W.B.H.B./C.P.W.D./P.W.D./Railway having credential for execution of building work or allied work of satisfactory completed works valued at least 20% of estimated amount in a single contract during last five years from the published N.I.T.

12. (a) Contractor has to submit completion certificate/Building progress certificate showing details of executed work and time taken for completion including comments on their up to date performance from the respective department/authority .
13. Contractor should submit application along with self attested copies of the following:-
(Original valid copies for each are to be produced for verification during submission)
- i) Income Tax Return with acknowledgement for the current year including PAN CARD
 - ii) Professional Tax(P.T.) latest challan with certificate.
 - iii) Employees Provident Fund(E.P.F.) Enrolment certificate with Code No. and last receipt.
 - iv) Sales Tax/Vat Registration particulars (FormNo. 3) & latest deposit challan.
 - v) Service Tax Registration certificate. With latest deposit challan.
 - vi) Work order and completion certificate from respective department.
 - vii) Valid Trade license.
 - viii) Power of Attorney/Authority to sign the Tender document & Article/Memorandum of Association (in case of Companies).
 - ix) In case of Partnership firm-Partnership Deed
14. Tender documents can be available from the office of the Dy. Director (EW)-SLG, at ABASAN (3rd Floor), West Bengal Housing Board, 105, S.N. Banerjee Road, Kolkata-14.
15. Constructional labour welfare **Cess @ 1(one) %** of cost of construction will be deducted from every bill of the selected agency. Vat, Royalty & all other statutory levy/Cess will have to be borne by the contractor and the rate in the schedule of rates inclusive of all the taxes and Cess stated above.
16. Tender documents must be purchased from the office of the Dy. Director(EW)-SLG . on receipt of cost tender document.
17. Tender must be accompanied by **Earnest money is 2%(two percent) of the estimated amount** put to tender in shape of Bank draft/Pay order on any Nationalized Bank drawn in favour of West Bengal Housing Board.
18. Tender must be delivered to Dy. Director (EW)-SLG, at ABASAN(3rd Floor), West Bengal Housing Board or in absence to any authorized officer of West Bengal Housing Board and will be opened on the same day in the presence of bidders or their authorized representatives.
19. Service Tax may be reimbursed by West Bengal Housing Board on receipt of relevant Document
20. If the office happens to be closed on the date of receipt of tender as specified in the NIT will be received and opened on the next working day at the same time and venue,
21. The post tendering negotiation if required may be made with all the eligible tenderers which may be instant or afterwards.

22. Contractor shall have to make his /her own arrangement for resource materials like steel and cement required for the work. Branded steel and cement (steel: SAIL/TATA/RINL brand and cement: ULTRAECH/AMBUJA/LAFARGE Brand) duly certified will only be accepted.
23. **There will be no provision for arbitration** whatsoever in the contract.
24. Revised clause 17 is applicable here as per decision taken in 506th. Meeting of WBHB in place of old one.
25. Successful tenderer would have to execute an agreement as specified by the WBHB in non- judicial stamp paper of value Rs. 10/-only before issuing of formal work order by the WBHB.
26. .No conditional tender will be accepted.
27. The Agency will quote the rate (in both words and figures) in the prescribed form of WBHB of the Tender documents,
28. Submission of false misleading and fabricated statement/ documents/information etc found at any point of time will lead to cancellation of the tender.
29. Acceptance of tender will rest entirely with the WBHB which does not bind itself to accept the lowest tender and reserves the right itself the authority to reject any or all the tenders received without assigning any reasons thereof.
