certificate, showing details of executed work and time taken for completion from respective department and their up to date performance and quality of executed works to fulfill criteria for qualification. The willing Participants should have valid currant Vat, Sell tax, P.F

- No conditional tender will be considered for acceptance.
- 14. Transfer of tender documents shall not be permitted.
- 15. The successful tenderer will have to execute an agreement as specified by the W.B.H.B. in non judicial stamp paper of value of Rs. 10 (Ten) on formal acceptance of tender. Acceptance of the tender will rest with the West Bengal Housing Board which does not bind it to accept the lowest tender and reserves to itself the authority to reject any or all the tenders received, without assigning any reason thereof.

- 18. 1% (One percent) cess will be deducted from successful Agencies bills, due to imposition of Constructional worker's welfare Act. 1996.
