NOTICE INVITING TENDER

Tender notice No. 04 of 2015 – 2016 of DD(EEW)-II.

Sealed Tender in prescribed printed form of the West Bengal Housing Board are invited by the Deputy Director(EEW)-II, WBHB, 105, S. N. Banerjee Road, Kolkata – 700 014 for the following work from eligible tenderers as particulars given below:-

1. Name of work. : Supply, Installation & Commissioning of 2 Nos. centrifugal pump motor set (25 HP,B.E Make) along with control panel board at pump room 3 for supply of drinking water at Shilpakanan Housindg Project, Phase-III, at Durgapur (for G + IV stored building nos. 1 to 12) under WBHB.
2. Tender Inviting authority. : Deputy Director(EEW)-II.
3. Name & Address of the concerned Engineering-in-Charge. : Deputy Director(EEW)-II, 105, S.N. Banerjee Road, Kol-14.

7. Date of opening of Tender. : 08.05.2015 at 3 p.m., shall be opened by the DD(EEW)-II, in his office in presence of the tenderers or their authorized representatives.
8. Estimated amount. : Rs. 4,75,700/-.
9. Initial earnest money. : Rs. 9,514/- (To be deposited by Bank Draft/Pay Order).
10. Cost of Tender paper. : Rs. 750/ per set, non refundable.
11. Time allowed for completion of work. : 15 days from the date of commencement.
12. Credential for fulfilling minimum Criteria for application. : The participating agencies must have experience in satisfactory completion certificate of works valued at least Rs. 1,91,000.00 in a single contract of similar nature, during last five years. The contractors should have credentials for executing such work under the organization like C.P.W.D/PWD/CENTRAL/State Govt. under taking. They shall have to submit completion certificate, showing details of executed work and time taken for completion from respective department and their up to date performance and quality of executed works to fulfill criteria for qualification. The willing Participants should have valid currant Vat, Sell tax, P.F Accounts Nos. (with current P.F. challan) and I.T. clearance certificate and credentials as applicable and to be shown and to be verified by the department before giving permission for purchasing the tender documents.

13. No conditional tender will be considered for acceptance.
14. Transfer of tender documents shall not be permitted.
15. The successful tenderer will have to execute an agreement as specified by the W.B.H.B. in non judicial stamp paper of value of Rs. 10 (Ten) on formal acceptance of tender.
Acceptance of the tender will rest with the West Bengal Housing Board which does not bind it to accept the lowest tender and reserves to itself the authority to reject any or all the tenders received, without assigning any reason thereof. The tender submitted in the first call is also allowed in the second call(as the case may be), if the tenderer desires to be participant in the second call also.
16. Validity of Tender is 120 days from the date of opening of Tender.
17. 1% (One percent) cess will be deducted from successful Agencies bills, due to imposition of Constructional worker's welfare Act. 1996.
18. Board will reimburse the service tax to the successful tenderer as per rule.
Tender shall be received only in Tender Box kept in the chamber of the DD (EEW)-II, WBHB.
All other relevant information will be available in the tender documents itself and details can be seen in the office of Deputy Director(EEW)-II, West Bengal Housing Board..
