Banerjee Road, Kolkata-700014 for the following work from eligible tenderer as per particulars given below. The tenders will be received by the Joint Director (EW)-III, WBHB at his office at 105, S.N. Banerjee Road, (4th floor), Kol-700 014 upto 1.30 p.m. on 01.02.2013. The tender shall be opened on the **same day i.e. on 01.02.2013 after 1.30 p.m. The tenders should dropped by the Tenderers in the Tender box kept at the above office of JD (EW)-III:-**

9. Credential for fulfilling minimum Criteria for application. : The participating agencies must have experience in
Satisfactory completion/billing progress of similar nature of

Work valued at least 40% of the estimated amount put to the tender in single contract during last five years. The Contractor should have credentials for executing such works under the organization like CPWD, P.W.D., Central/State Govt. Undertaking/Organization, Joint Venture Company/Associated Sector company with WBHB as per enclosed format in Annexure-A. They shall have to submit completion certificate/billing progress showing details of the executed work and time taken for completion from the respective Department/authority and their up to date performance and quality executed works to fulfill minimum criteria for application.

Successful tenderer would have to take Cases Registration certificate with the Labour Department Govt. of West Bengal located in the area where the construction project is to be executed.

Under registration certificate can be shown, the Work-order shall not be issued.

The

Contractors should submit the specific Bank solvency certificate minimum 20% of the estimated amount put to tender) for the works to be executed under specific Tender Contract under specific N.I.T. The Bank certificate issued by the Bank specifying the works should be Valid for the said works only for which the Bank solvency certificate is required.

A suitable technical staff having Diploma Holder in Civil & Electrical Engineering as the case may be is to be engaged by the tenderer at the working site as site- in-charge for the work & valued from Rs.75 lacs to Rs.3

Cores and technical staff having B.E. Degree of equivalent (Civil & Electrical) as the case may be is to be engaged as site as site-

In-charge for the works valued above 3-Cores. In case the agency is unable to deploy such Tech. personnel's i.e. Diploma Holder(Civil & Electrical) at working site a penalty @Rs.10, 000/- & Rs.15, 000/- Per Month respectively will be deducted from their R/A bills and final bills.

The Agency should possess service Tax Registration Number & necessary documents should be submitted by the Agency to the Department to this effect. The service Tax may be reimbursed to the Agency on production of necessary documents by the agency in due course

The Agencies who have participated in the 1st Call (NIT NO:04 of 12-13 of JD(EW)-III dated 29.11.12)of this tender need not applied fresh, however in case of any of the participants of the 1st call like to participate a fresh then they have to complied with all norms and terms and conditions as stated in the tender documents (for 2nd call) itself, they are submitted tender in the 1st call will be automatically treated as canceled and Earnest Money already deposited (1st Call) will be refunded on application after the date of opening of the 2nd call of the tender. The price Bids of the tenderers of the 1st call has not been opened. The Price Bids of all tenderers eligible in Technical Bids for both 1st & 2nd Call will be open simultaneously. As 2nd call of the NIT invited keeping the 1st call alive (with condition indicated in the 2nd "Call of N.I.T.)

10. No conditional tender will be considered for acceptance.

11. Transfer to Tender Documents shall not be permitted.

12. The successful tenders will have to execute an agreement as specified by the West Bengal Housing Board in Non-judicial stamp Paper of Value of Rs.10/- only before issuing for formal work order.

13. If required seal bid/table negotiation will be held with the participating tenderers.

14. Acceptance of tender will rest entirely with the WBHB which does not bind itself to accept the lowest tender & reserves the right itself the authority to reject any or all the tenders received, without assigning any reason thereof.

15. If the office happens to be closed on the date of receipt of tender as specified in the NIT will be received and opened on the next working day at the same time and venue.

16. **1(one) %** Cess will be statutory deducted from each of contractor's progressive bill.

17. Validity of Tender: 180-Days from the date of opening of tender.

Tenders shall be received only in Tender Box kept in the Chamber of the J.D. (EW)-III, WBHB. All other relevant information will be available in the tender documents itself. Tenders shall be received only in Tender Box kept in the Chamber of the J.D. (EW)-III, WBHB and nowhere else. All other relevant information's perquisite to the tender will be available from the office of the J.D. (EW)-III, WBHB during office hours.

Submission of False, Misleading, and Fabricate of Statement/Documents/Information etc. will be lead to cancellation of the tender.
