**NOTICE INVITING TENDER**

**Tender notice No. 05 of 2015 – 2016 of DD(EEW)-II.**

Sealed Tender in prescribed printed form of the West Bengal Housing Board are invited by the Deputy Director(EEW)-II, WBHB, 105, S. N. Banerjee Road, Kolkata – 700 014 for the following work from eligible renderers as particulars given below:-

- 1.a. Name of work. : IEI of Management Office, Switch Room at Shilpakanan Housing Project Phase-III & temporary Electrical loop connections at 24 Nos. Lift Machine Room for lift installation work at Shilpakanan Housing Project Phase-III.
- b. Estimated Amount. : Rs. 1,20,380=00.
- c. Name & Address of the concerned Engineering-in-Charges. : Deputy Director(EEW)-II. 105, S. N. Banerjee Road Kolkata – 700 014.
- d. Earnest Money. : Rs. 2,408=00 (Rupees Two thousand four hundred Eight ) only to be deposited by bank draft/pay order only on a Nationalised Bank at Kolkata in favour of .B.H.B. along with the tender as initial earnest money without which tender will be rejected. No cash cheque or challan or token will be accepted for Earnest money. Earnest money of the unsuccessful tenderers shall be refunded without any interest on application only after acceptance of favourable tender.
- e. Tender form in which tender is to be submitted. : Tender and contract form of the Board.
- f. Price per set of Tender document. : Rs.250=00 (Rupees Two hundred fifty) only non refundable to be deposited in case section of the Board within 2 P.M. on the date(s) specified for sale of tender documents.
- g. Last date & time limit for receipt of application seeking permission for purchasing the tender document : Any working day between 11.00 A.M. to 1.30 P.M .From 11.5.2015 & 12.5.2015.
- h. Date(s) of Sale of Tender document. : From 12.00 Noon to 3 P.M. on 11.5.2015 & 12.5.2015.
- i. Last date & time limit for receipt & opening of tenders. : The tender will be received on 14.5.2015 up to 2 P.M. The Tender will be opened by the Deputy Director (EEW)-II, WBHB at his office at 105, S. N. Banerjee Road (4th floor) Kolkata -14 in presence of the intending tender or their authorization representative holding written authorization on the same day i.e. on 14.5.2015 at 3 P.M.
- j. Time completion of Work. : 15 (fifteen) days from the date of commencement.

2. No conditional tender will be considered for acceptance.
3. Transfer of tender documents shall not be permitted. The successful tender will have to execute agreement as specified by the W.B.H.B. in non judicial stamp paper of value of Rs. 10 (Ten) non formal acceptance of tender.  
Acceptance of the tender will rest with the West Bengal Housing Board which does not bind it to accept the lowest tender and reserve to itself the authority to reject any or all the tender received, without assigning any reason thereof.
4. Contractor eligible to submit tenders : The participating agencies must have experience in satisfactory completion certificate of works valued at least Rs. 48,200.00 in a single contract of similar nature, during last five years. The contractors should have credentials for executing such work under the organization like C.P.W.D/PWD/CENTRAL/State Govt. under taking. They shall have to submit completion certificate, showing details of executed work and time taken for completion from respective department and their up to date performance and quality of executed works to fulfill criteria for qualification. The willing Participants should have self attested copies of valid partnership deed (in case of partnership firm), Articles/Memorandum of Association (in case of Companies), current Professional Tax Deposit Challan with Professional Tax Registration Certificate, Current Value Added Tax Deposit Challan with VAT Registration Certificate, PAN Card, Recent Income Tax Return with Acknowledgement, valid Trade License from the respective Municipality/ Panchayat, valid Electrical Contractors' License, Power of Attorney/Authority to sign the Tender Documents (in case of companies) , valid PF Registration Certificate with current deposit challan, valid Service Tax Registration Certificate with current deposit challan etc
5. Detailed particulars and availability of tender document : Detail particulars of the work may be seen during working hours at the office of the Deputy Director(EEW)-I. Tender documents will be available from the office of the Dy. Director(EEW)-I, WBHB on date and time specified for sale of tender documents on production of money receipt issued by the cashier of cash section of the Board towards the cost of tender documents, No tender documents will be issued after the date and time fixed for sale of tender documents.
6. If required sealed bid may hold among the participant contractors to be intimated later.
7. 1% (One percent) cess will be deducted from successful agencies bills, due to imposition of Constructional worker's welfare Act. 1996.
8. Board will reimburse the service tax to the successful renderer.
