Sealed Tenders in prescribed printed form of West Bengal Housing Board are invited by the JD(EEW) from the intending tenderers for the work with following particulars :-

1. Name of Work: - Regular attendance of Electrical Installation of Temporary site office at phase –VB, Sodium Vapour lamps at common Roads including maintenance of existing cement and Steel Godown (at Phase – V) of Thakurpukur Housing Project ( Prantik ) for 6 (six) Calendar months.
2. Tender Inviting Authority : Joint Director (EEW).
3. Name & Address of the E.I.C. : Deputy Director (EEW)-I, Thakurpukur H.P.

9. Date of Opening of Tender : 28/01/2013 at 3 p.m., shall be opened by the JD(EEW), in his office in presence of the tenderers or their authorized representatives.
10. Estimated Amount : Rs 74,435/-
11. Initial Earnest Money :Rs.1489/-being 2% of Est. amt.put to tender by DD/PO/BC, in favour of W.B Housing Board on any Nationalised Bank Payable at Kolkata.
12. Cost of Tender paper : Rs.250/-(Rupees Two hundred fifty) only (non-refundable) to be deposited in cash section of the Board within 3-P.M.
13. Time allowed for completion of work : 6 (Six) Calendar Month from the date of commencement of work as per work order.
14. Credential for fulfilling minimum Criteria for application : The participating agencies must have experience in satisfactory completion/payment certificate of work valued at least 40% of the est. amt. put to tender in a single contract of similar nature, during last five years. The contractors should have credentials for executing such work under the organization like C.P.W.D./PWD/Central/State Govt. under taking, organization, joint venture Company/Associated Sector, with WBHB. They shall have to submit Completion Certificate/payment certificate, showing details of executed work and time taken for completion from respective department/authority and their up to date performance and quality of executed works to fulfill criteria for qualification. Successful tenderer would have to take cess registration certificate with the labour department, Govt. of West Bengal located in the area where the construction project is located. Unless Labour registration is shown, the work order shall not be issued. The agency should possess valid Trade license , Electrical Contractor License with Electrical Supervisory Certificate ,Service Tax Registration No., P.F Enrolment No, upto date Income . Tax clearance certificate, Professional Tax (Deposit challan), Pan card, VAT Regn and copies of relevant documents are to be accompanied with the Technical documents. The service tax may be reimbursed to the agency on production of necy. Documents in due course.
15. No conditional tender will be considered for Acceptance.
16. Transfer of Tender documents shall not be permitted.

17 The successful Tenderers will have to execute an agreement as specified by the WBHB In Non Judicial Stamp paper of value Rs.10.00 only before issuing formal work order.

18 If require a sealed bid/ table negotiation will be held with the all eligible tenderers.

19. The Tender is valid for 180 days from the date of dropping.

20. There will be no provision for Arbitration whatsoever in the contract.

21 Acceptance of tender will rest entirely with WBHB which dose not bind it self to accept the lowest tender and reserves the right to reject any or all the tender received, without assigning any reason there of.

Tender shall be received only in Tender Box kept in the Chamber of the JD(EEW), WBHB, and no where else. All other relevant information will be available in the tender documents it self.

. All the relevant information's perquisite to the tenderer will be available from the office of the JD(EEW), WBHB during office hours.
