- 7.Quotation must be delivered to Deputy Director(EW) Siliguri Housing Project West Bengal Housing Board or in absence to any authorised officer of West Bengal Housing Board in the Tender box kept in his chamber. Quotation will be opened in the presence of bidders or their authorised representative in the same venue. If the office happens to be closed on the date of receipt of bids as specified the bid will be received and opened on the next working day at the same time and venue.
- 8. Successful quotationer would have to take cess registration certificate with the labour Department, Government of West Bengal location in the area where the construction project/work is to be executed under specified NIT.
- 9. Successful quotationer would have to execute an agreement as specified by the W.B.H.B. in non-judicial stamp paper of value Rs.10/- before issuing of formal work order by the W.B.H.B.

- 10. 1%Cess will be statutory deducted from each of agencies bill.
- 11. No conditional quotation will be accepted.
- 12. If required seal –bid /table negotiation may be held with the lowest quotationer which may be instant or afterward.
