The envelope containing earnest money and Technical bid with pre-qualification documents shall together constitute Part-A of the offer and shall be placed in a large outer envelope properly sealed with clear superscription PART-A(TECHNICAL BID).

13. Part-B/Price bid.

The Agency will quote the rate (in both words and figures) in the prescribed form of WBHB of the Tender documents,
