1. Name of the work : Providing 2(two) No M.S. gate and allied works at Calcutta Green H.P., Ph-II under WBHB
2. Estimated amount put to Tender Rs. 1,52,248.00

4. Bonafide and resourceful contractors working at West Bengal Housing Board , State P.W.D. , C.P.W.D. , M.E.S.
