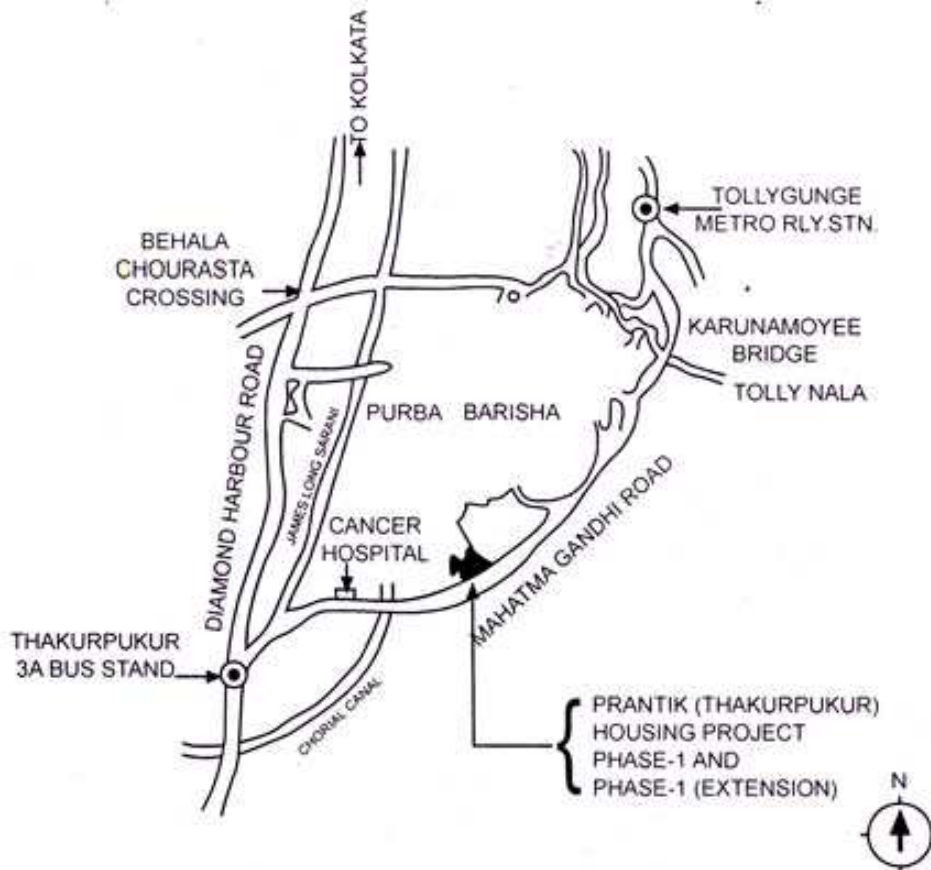
PREFACE

1. LOCATION :

KEY PLAN

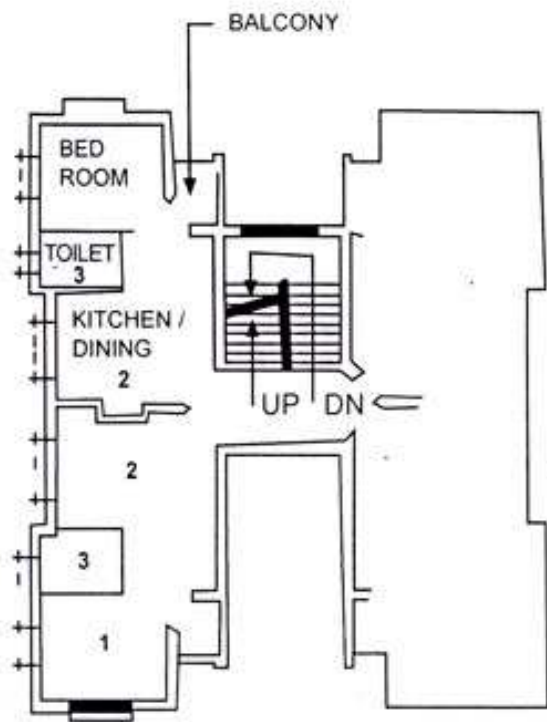


2. FACILITIES AVAILABLE IN THE LOCALITY (OUTSIDE THE SCHEME)

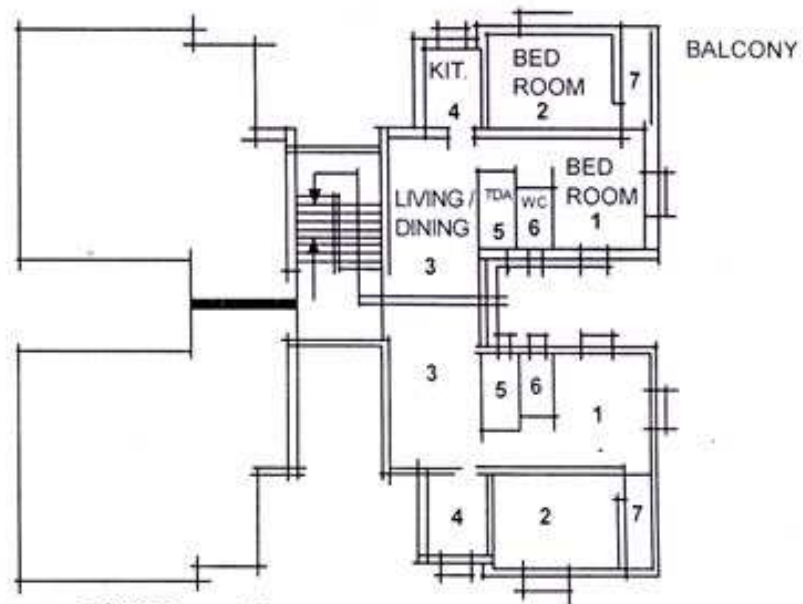

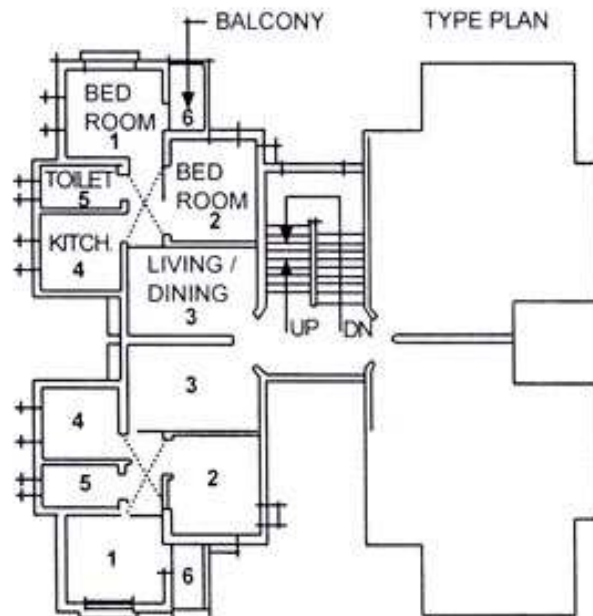

3. GENERAL FACILITIES :

- i) There will be provision for internal Electrification for each D.U. But the allottees will have to make their own arrangement for connection from electricity supplying authority.
- ii) Arrangement for water - supply will be made.
Allottees will have to take membership in the existing Co-operative Housing Society for operation & maintenance of flats.
- iii) Swages from toilets will be disposed of through septic - tanks.
- iv) Internal Roads, pathways and street - light will be provided within the complex.
- v) The operation and maintenance of internal water supply system, compound lighting, sewer line, surface drains, internal roads, pathways, children's tot -lots etc. will be the sole responsibilities of registered Co - operative Society.
- vi) There are few pockets of land with houses thereon belonging to private individuals which are excluded from the project area. But such houses with plots will be integrated with the Housing complex being undertaken by the west Bengal Housing Board so far as these individuals will have the right to use the compound roads & drainage system. They will however make their own arrangement for water supply and electricity to their dwelling units through the common areas.

4. Mode Of Payment

- i) Full consideration money for the flats should be paid within 60 days from the date of issue of allotment letter.
- ii) The Board may , however, at its discretion and on the prayer of the allottee extend the time to a maximum period of 120 days with a penal interest @ 18% p.a. for this period. Failure to pay within this extended period of 120 days, the allotment shall stand cancelled without any further reference to the allottee.
